Tim is a tenacious and passionate litigator with more than 30 years' experience litigating complex cases. Tim has been a lead attorney on numerous high-stakes and high-profile cases, including the trial of the first wildfires class action in history against PacifiCorp, in which the jury found in favor of the class after a two-month trial; and the Aequitas Ponzi scheme class action, in which Tim and his team recovered \$234.6 million for investors, which is believed to be the largest recovery in a securities case in Oregon history. He is currently representing investors in a \$100 million proposed breach of contract class action against NuScale Power and Fluor Corporation and a \$1 billion GPB Funds Ponzi scheme class action, in which Tim is lead counsel for the claims against the auditors.

Tim's practice focuses on class action, securities, complex business and intellectual property litigation matters. Tim regularly litigates matters involving securities and financial fraud, Ponzi schemes, stockbroker malpractice, and violations of state and federal securities statutes; patent infringement, trademark infringement, trade secrets and copyright infringement; consumer class actions; and shareholder derivative and fiduciary duty claims.

Prior to joining the firm, Tim held a two-year clerkship with Hon. Robert E. Jones of the United States District Court (Oregon). 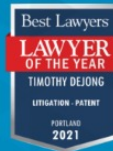
